

You must present this card **OR** your current NAR-issued ID card to purchase or renew your Alabama REALTOR® auto tag.

This postcard OR your NAR-issued ID card provides proof of your REALTOR® membership.

Your tax-deductible purchase of an Alabama REALTOR® auto tag will benefit the Children's Trust Fund of Alabama which works to prevent child abuse and neglect in our state.

The cost of the REALTOR® tag is \$50. Of that, \$45.75 goes directly to the Children's Trust Fund and is the tax-deductible portion. Children's Trust Fund does not charge administrative fees so \$45.75 goes to help children in need.

Alabama REALTOR® auto tags are for REALTORS® only.
