2 True confidential listing requires written authorization of property owner.

3 Clock starts the instant knowledge of defect becomes known.

4 Unless Participant gives cooperating Participant specific authority to show and/or negotiate directly.

5 After reasonable effort, cooperating Participant cannot contact the listing Participant.

6 All complaints should be handled Broker to Broker. If this is not possible then a compliant should be filed with Association Executive.

7 Listing cannot be expired or Withdrawn for a period of NO LESS than 30 days before it can be entered as a NEW listing

8 Where applicable, the primary photo is to be of a habitable structure and if possible, a photo of the lake side view of the structure.

9 Must be corrected/removed with 24 hours
